- **Get smarter data sets** using keywords extracted during the prioritization process to make keywords generated by the litigation team more robust and effective while overcoming challenges of under or over inclusion of traditional keyword methods.
- **Reduce costs by 25-50%** saving valuable time and resources during review with faster access to the most relevant data, which is typically only a fraction of the entire collection.

Here's how it works. After the CaseVault team receives the data set, a three-phase process is initiated:

Phase I: Reduce

- The collection set is de-duped, de-NISTed and then loaded on to the hosted platform.

Phase II: Prioritize

- 40 documents are selected at random and presented to a designated reviewer to determine relevance.
- CaseVault Precision analyzes the selection and through an iterative, self-correcting process feeds 40 new documents to the reviewer.
- Once a threshold of accuracy is achieved, the system ranks the entire collection.

Phase III: Review

- After scoring every document for relevance and responsiveness, the entire collection is loaded onto our hosted platform and ready for review.
