

Terms and conditions of entry

§1 Subject

These terms and conditions of participation apply to the HPE 'Jump for AI' online game competition, on the <https://jumpforai.ext.hpe.com> website.

The competition is run by Hewlett-Packard GmbH ("HPE"), whose registered office is located at: Herrenberger Strasse 140, 71034 Böblingen, Germany.

Participation in the competition is subject to the following terms and conditions of entry.

§2 Participation

There will be 4 competitions running throughout this campaign. The participant will be eligible to enter all 3 for a chance to win a prize.

The first competition will run from the [25th January 2022](#) until midnight (CET) on [25th March 2022](#). The second will run from the [25th January 2022](#) until midnight (CET) [23rd February 2022](#). The third will take place from the [25th January 2022](#) until midnight (CET) on the [9th March 2022](#). The fourth will take place from the [25th January](#) until midnight (CET) on the [23rd March 2022](#).

Each competition is open to residents of **Germany, Austria and Switzerland only** who are 18 years or older at the time of the respective competition. Employees of HPE and affiliated companies in accordance with §§ 15 ff AktG (German Stock Corporation Act) and their family members are not permitted to enter. Participants may not be employed or participate in the competition on behalf of - or in their quality as representative of a public sector entity or are otherwise vested with public administrative authority. Only one participation per person per competition is permitted. Automated or third-party entries will be disqualified.

1st Competition: - If participants score 500 points or more, they will be invited to submit their score to the leader board. Participants who have submitted their score to the leader board and are in the top 30 in the leader board at the closing time of the competition (23rd March) will win a prize. If participants do not score 500 points or more, they will be prompted to try again until they are able to submit their score to the leader board.

2nd Competition: - The first 15 participants to register to the first webinar 'Jump for AI: Explore the possibilities of AI with HPE & NVIDIA' (Healthcare), being shown on the 23rd February 2022 will win a prize.

3rd Competition: - The first 15 participants to register to the second webinar 'Jump for AI: Explore the possibilities of AI with HPE & NVIDIA' (Financial sector), being shown on the 9th March 2022 will win a prize.

4th Competition: - The first 15 participants to register to the third webinar 'Jump for AI: Explore the possibilities of AI with HPE & NVIDIA' (Manufacturing), being shown on the 23rd March 2022 will win a prize.

The competitions are free to enter. Participants must ensure that any of their personal information submitted via the game over screen and webinar registration portal is accurate, otherwise they may be excluded from receiving their prize. Automated or third-party entries will be disqualified.

§3 Prize/Announcement of winners

For each of the competition's participants have the chance to win a co-branded HPE & NVIDIA hoodie in either S, M, L, XL, XXL sizes. No colour options available. **No cash alternative will be offered, and a cash payment of the prize is not possible.**

Participants agree to be contacted by a 3rd party supplier to organise size and delivery of prize.

The winners of the competitions will be contacted by an agency and a game provider appointed by HPE, TBT Marketing Limited, 7 High Street, Rode, Frome, Somerset, BA11 6NZ, United Kingdom ("TBT") and Dowlis, Woking eight, Unit 2, Forsyth Rd, Woking GU21 5SB, United Kingdom ("Dowlis") via email. Participants will be contacted within a week after the end of the respective competition. Participants must reply to this email within 2 weeks to claim their prize. By entering the competition and sharing their game scores across social media participants give their consent for HPE to share their post across HPE social media profiles including LinkedIn and Twitter. The winner must confirm to HPE that their acceptance of the prize is not in violation of any law, regulation, or directive to which they are subject as an official or company representative.

Prizes will be sent by post to an address within **Germany, Austria, or Switzerland** to be provided by the winner on the prize acceptance form.

§4 Data protection

In order to be able to run the competition, participants' personal information (e.g. full name, telephone number, email address, address), will be processed by Hewlett-Packard GmbH and by Hewlett Packard Enterprise Group companies or its respective subcontractors TBT and Dowlis as required for the purpose of running the competition. This data will be deleted after the prizes have been given to the winners. This does not apply where further processing is permissible elsewhere, for instance for the purpose of legal prosecution. Participants may withdraw their consent to the processing of their personal data at any time by email. This will rule out their participation in the competition as it will no longer be possible to contact the participant once their data is deleted. §5 Anticorruption and bribery

HPE is subject to the provisions of the US Foreign Corrupt Practices Act (FCPA), the UK Bribery Act and other worldwide anti-corruption laws.

These laws prohibit the payment or giving of anything of value, providing other benefits, either directly or indirectly, by any HPE subsidiaries or affiliates, to commercial or non-commercial organizations, an official of every government, every political party, party official or candidate for every public or political office for the purpose of influencing an act or decision in their official capacity, or inducing them to use their influence with every government, to assist HPE, or any of its subsidiaries or affiliates, in obtaining or retaining business for or with, or directing business to, any person.

Participants agree that they will not take any action that would cause HPE to be in violation of the FCPA, UKBA or any other applicable worldwide anti-corruption laws or regulations and undertake to duly notify HPE if they become aware of any such violation.

§6 Miscellaneous

These terms and conditions of entry may be amended at any time by HPE without notice. The competition organiser's decision is final.

If any individual clause within these terms and conditions of entry should be or become invalid, the validity of the remaining terms remains unaffected.
