My main task is to keep these plants supplied with all the raw materials they need to maintain production. I must make strategic purchasing decisions for our business – what to purchase and when, and how to keep costs to a minimum. In doing so, it's my responsibility to build and maintain supplier relationships, negotiate on pricing where necessary and undertake product comparisons if no specifications were provided.

Where market conditions allow, I will negotiate with suppliers to secure lower prices for the materials I am sourcing. When feedstock prices rise, I need insights that will verify and justify these increases, so that in turn our commercial team can be informed and work out a solution to protect our profit margins.

Juggling short-term priorities, strategic procurement decisions and contract tenders requires a panoramic view of key markets. Reliable insights into industry trends are essential to facilitate informed choices, which can be substantiated in my monthly reports to senior management.

#### How ICIS helps me
